Professor Hank Jenkins-Smith, the University of Oklahoma (US) (9am via video-link)

Professor Hank Jenkins-Smith is a Professor of Political Science at the University of Oklahoma where he is currently a Co-Director of the University's Center for Risk and Crisis Management. He is also a Co-Director of the Center for Energy, Security and Society, a joint research center of the University of Oklahoma and Sandia National Laboratories focused on issues such as nuclear facility siting, nuclear security and national security. Professor Jenkins-Smith obtained his PhD in political science and public policy from the University of Rochester in 1985. His work in recent years has focused on public understanding and response to a range of societal risks, including climate change, nuclear technologies, natural disasters, radioactive materials and vaccines.

Professor Daniela Stehlik, Australian National University (11am)

Professor Stehlik is an Adjunct Professor at the Australian National University, James Cook University and Queensland University of Technology. She is also currently the Chair of the Rural Industries Research and Development Corporation. She earned a Bachelor of Arts in English, History and Philosophy from the Australian National University in 1986, a Master of Social Science from Edith Cowan University in 1992 and a PhD in philosophy from the University of Western Australia in 1998. Professor Stehlik authored the 2010 National Academies Forum report, Understanding the Formation of Attitudes to Nuclear Power in Australia, which explored the influences on the public debate around nuclear power in Australia.
